

CONTRACT FOR USE OF FACILITIES

IT IS HEREBY AGREED by and between _____

following conditions.

I. LIMITATION OF PERSONS

The undersigned agrees and acknowledges the only individuals authorized to participate in the sport/activity listed above, around or on the property of Christ's Family Church, Davenport, Iowa are those listed on the attached Exhibit A. Spectators are permitted, however minor children must be under adult supervision.

II. FEE.

Charges for the use of these facilities will be as follows:

There will be no further charges provide that no damage to the property has occurred and no additional work is required.

III. REGULATIONS GOVERNING USAGE OF FACILITIES.

All organizations and individuals using the Church facilities will observe the following regulations:

- a. Groups shall arrive and leave the facilities at the contracted times.
 - b. No extra work will be left for custodians.
 - c. The facilities used are to be left in the SAME condition in which the Group or individuals found them.
 - d. Groups and individuals are required to provide their own equipment (Including, but not limited to balls and towels)
 - e. Gym shoes are to be worn when groups or individuals are participating on gym floors and they must be cleaned or not worn into building from outside..
 - f. Group participants are to remain only in their contracted area of the Family Life Center building.
 - g. Minor age children must have adult supervision at all times.'
 - h. Any damage to Church property is to be reported immediately to Church authorities. Damage to property and equipment incurred during the time the facility was in use shall be paid for by the group or individuals using the facility.

- i. All Church property shall be off limits to gum products or tobacco products of any kind. Persons failing to abide by this request shall be required to leave the Church building and grounds immediately.
- j. There shall be no alcoholic beverages brought to or consumed in the Church building or on the grounds.
- k. No one is allowed in the building either before or after the organization or individuals specified time of use.
- l. Violation of any of these policies may result in the loss of privilege of any further church use.

IV. ASSIGNMENT

There shall be no assignment of this Agreement.

V. INDEMNITY

The undersigned agrees to indemnify and hold harmless Christ's Family Church, Davenport, Iowa, its officer, agents, servants, and employees harmless for any cause of action brought against Christ's Family Church, Davenport, Iowa resulting or arising from the usage of the property, or presence on the property, of Christ's Family Church, Davenport Iowa, including the amount of reasonable attorney fees incurred in the defense of Christ's Family Church, Davenport, Iowa, its officers, agents, servants or employees, of any action brought against them.
